### REGISTRATION FEES

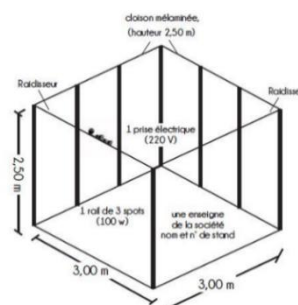
Registration fees include: the application fees, the compulsory premium insurance (see details in the Exhibitor's Guide), mention of contact details and activity in the official program and the electronic catalog of the show, 1 exhibitor parking card, exhibitor tradeshow badges giving access to the exhibition area only, with extended hours (2 exhibitor badges + 20 free invitations with a 9 sqm booth reservation / 4 badges + 40 free invitations with a 18 sqm booth reservation). The parking card and exhibitor badges will only be handed after full payment of the total amount of your participation and at the latest the day before the opening of the show. Compulsory and supplementary insurance (see Article 18 of the Regulation).

The theft guarantee will be effective from the first public opening hour until the last hour of the closing day.

### EQUIPPED BOOTH

EQUIPPED BOOTH, 9 sqm delivered and furnished with:

- melamine stand partitions, height 2.5 m, with stiffeners,
- needled carpet, filmed, color NUT 0916
- a sign (text to be filled in on page 1),
- 3 kW electrical connection

The stud owners booths are grouped and located in the entrance of the exhibition, close to Baloubet arena and stables. The visit of the stallion stables is possible under control and in the presence of the stud owners.

### CONDITIONS OF PARTICIPATION - STALLIONS PRESENTATIONS

The number of presented stallions is limited to 60, except the stallions entered in the competitions As Pony Elite and CSI5\*W. Participation on OC invitation, only open to stallions approved in one of the WBFSH studbooks, jumping, eventing or dressage orientation.

The number of stallions presented by stud owners is not limited. Stud owners undertake to respect the instructions, the running order and the schedules of the event.

#### Conditions of participation:

- 3 & 4 years old : approved and passed the tests, "Very Promising" or "Hope"
- 5 to 8 years old : ranked "Elite" or "Excellent" in one of the SHF finals or qualified for one of the World Championship Finals / or approved "Very Promising" / or in the "Elite" category or "Very Good" in the SIRE database
- 9 years old and over : "Elite" or "Very Good" genetic category in the SIRE database / or ISO  $\geq$  160

Mandatory presentation of all stallions on Friday (07/02) and Saturday (08/02).

Deadline for presentations applications: January 6<sup>th</sup> (only complete files with full payment will be accepted).

Announcement of selected stallions: before January 13<sup>th</sup>

The presentation fee of a stallion includes the rental of 1 stable box for 3 days (Thursday-Saturday), the supply of sufficient straw / shavings / hay, the registration of the stallion in the catalog of the Stallions Show. Each stud owner who registers one or more stallions will receive 3 accreditations cards with access to the arena and stallion stables (quota per stud owner, not per stallion). The stallions remain under the full responsibility of the stud owners during all the time of their presence in Bordeaux. Under no circumstances can the liability of the organizer, its directors or volunteers be involved.

## EVENT RULES

**PREAMBLE** - The Supplementary Regulations set out the particular conditions of the service provided to the exhibitor by the organizer. It is supplemented, in case of a gap, by the supplementary provisions of the General Regulations of the commercial events (RGMC / 2015) of UNIMEV, professional federation to which the organizer is a member. The Exhibitor acknowledges having read this RGMC and accepts all the terms. In the case that he does not have an internet access, he undertakes to request from the organizer, before signing the participation contract, a paper version of this regulation, which he will be aware of and accept the terms.

**DATE AND DURATION** - Article 1 - If, due to force majeure or any event beyond the Organizers' control, it becomes impossible to obtain access to the necessary premises, thus making it impossible to do everything required to hold the event, the Organizers may cancel exhibition space reservations at any time, by informing the exhibitors in writing. No compensation or indemnification will be due in this case, irrespective of the reasons for this decision. Any sums remaining available, after payment of all expenses, will be distributed among the exhibitors proportionally to the sums they paid, and exhibitors expressly agree not to make any legal claims against the Organizers, under any heading and for any reason whatsoever, or to sue for damages or claim compensation for breach of contract.

The Organizers may cancel or postpone the event if the number of exhibitors registered is substantially inadequate. Deposits or exhibition fees will be refunded to registered exhibitors. Until the closing day for registration, exhibitors accept all risks related to the possible failure to hold the event and, in particular, they are exclusively liable for any expenses incurred in preparing for the event.

**CHECKING AND ACCEPTING APPLICATIONS** - Article 2 - Only one site will be allocated to each brand. If the application is not signed by the manufacturer, applicants must submit the manufacturer's approval for products to be exhibited to the Organizers. Applications are accepted subject to approval. The Organizers may decide to admit or refuse applicants at any time, and will not be obliged to give reasons for their decision. Applicants whose applications are refused cannot argue that they have been admitted to previous exhibitions, nor that their application was invited by the Organizers.

Correspondence between the applicant and the Organizers or the fact that the registration fees have been cashed, or even the publication of the applicant's name in a list of any kind, cannot be cited as proof of admission. Rejection of an application will not entitle the applicant to any indemnity other than the reimbursement of any sums already paid to the Organizers. Admission to one event does not imply eligibility for admission to any later event. The Organizers have the right to retain handling charges or registration fees, whatever the outcome of the application.

**MEMBER'S OBLIGATIONS** - Article 3 - Once a membership application has been confirmed, it constitutes a final, irrevocable commitment by the member, who is, consequently, liable to pay the total amount invoiced. Signing the membership form entails the obligation to occupy the allocated stand or rental space at least 24 hours before the opening of the event, leave the installation in place until the exhibition closes, and remove any merchandise only after the closing of the event, in application of the conditions specified in the exhibitor guide.

Paying the membership fees implies acceptance of these general and special regulations and the general terms and conditions of sale, as well as regulations concerning public order, police, and safety that have been, or may in the future be, issued by the authorities or the Organizers. Any breach of these general and special regulations may result in the immediate, temporary or permanent expulsion of the exhibitor, without any compensation or reimbursement of sums paid and without prejudice to any legal claims that may be brought against them.

**OFFICIAL ADDRESS** - Article 4 - For the duration of the event, including setting up and stand clearance, Exhibitors declare that their official address will be that of the site allocated to them on the exhibition premises.

**PAYMENT** - Article 5 - The total rental is due upon signature or electronic confirmation, as specified on the membership request form. Exhibitors agree to inform their banks of the amounts to be paid on the due dates indicated, by recovered bill of exchange, bill of exchange, or promissory note. All sums owed to the Organizers that are not paid by the due date will automatically bear interest, without any further notification being required, at a rate calculated at three points above the current basic bank rate on the date the payment was due. Furthermore, in keeping with French decree no. 2012-11-15, any debtor who has not respected the payment deadline must pay, as of right, a flat rate indemnity of 40. In case of legal proceedings for nonpayment, the Organizers reserve the right to apply an irreducible, flat-rate penalty clause representing 15 % of the total sums due, without prejudice to any claim for damages or compensation on the basis of article 700 NCP.

It is expressly agreed that any equipment, installations, and merchandise on the stand or space allocated to the exhibitor are specifically pledged to the Organizers as security for their debts. In application of this contract, in case of failure to pay the sums due, the Organizers may rely on this pledge to retain the property until full payment is received, under the terms of the lien agreement annexed to the pledge contract. In this case, the Organizers issue a final notice reiterating this clause and may then call in a Bailiff to inventory the property retained and prohibit it from being removed.

**FAILURE TO OCCUPY** - Article 6 - The invoice amount remains due by Exhibitors under all circumstances. Stands or sites that have not been occupied 24 hours before the opening of the event may be allocated to another firm and the applicant who has not taken possession of the site may not claim any damages whatsoever, not even the reimbursement of sums already paid.

**NO TRANSFER OR SUBLETTING** - Article 7 - Transfer of all or part of a stand or site to another Exhibitor is prohibited. However, if the Organizers agree, several manufacturers in a similar sector may occupy a stand jointly, provided that each Exhibitor pays the requisite handling charges.

**DECLARATION OF ITEMS EXHIBITED** - Article 8 - Exhibitors must provide a full list of all the products they intend to exhibit on their application form (see page for catalogue). Applicants who are agents or brokers must also list the names and addresses of the companies whose products they intend to exhibit. The Organizers reserve the right to remove without notice any product not included on the application form, or to expel any firm that has not been approved under the aforementioned conditions, without prejudice to the application of the sanctions specified in article 4 of these regulations to the offending firm.

**PROHIBITED PRODUCTS** - Article 9 - Explosives and, in general, all dangerous or harmful products are prohibited. The operation of apparatus, and the installation or distribution of objects likely to be annoying or dangerous for other Exhibitors or visitors are prohibited. Lighting fires in the exhibition halls is also prohibited. The exhibitor shall allow the organizer to verify at any time that there are no private aerials on his stand(s). In the event the exhibitor refuses, electric power to the stand(s) will be suspended.

**MODIFICATIONS TO INVENTORY** - Article 10 - When Exhibitors take possession of the stands they have been allocated, they must notify the Organizers of any existing damage to their site. Claims must be presented to the Organizers on the day Exhibitors take possession of their sites, otherwise any repairs required will be invoiced to them. Digging in the ground under the stands, cutting or damaging partitions, floors, or ceilings, or any of the equipment provided by the Organizers in any way whatsoever is prohibited. Installation of bearings, saddles, transmissions, or motors, i.e. using walls, posts, or floors of stands as supports for heavy weights or mechanical stresses is strictly prohibited. In case of any breach of this regulation, Exhibitors will be held fully liable for any damage, annoyance to neighbouring stands, or accidents, without prejudice to application of the sanctions specified in article 4 of these regulations.

**ARCHITECTURE COMMISSION** - Article 11 - In the context of the overall presentation and decoration scheme for the event imposed by the Organizers, this commission is responsible for examining all individual construction or installation projects envisaged by Exhibitors (mezzanines, advertising or decorative designs, illuminated signs, animation, etc.). Banners are strictly prohibited in all cases. Sides of stands adjacent to aisles must not be closed with full partitions.

**SPECIAL WORK** - Article 12 - Applicants whose installations require special work (earthworks, pipes, removal of partitions, reinforced floors, etc.) must give details in the "observation" section on the application form, indicating, as far as possible, the extent of the work required. Removal of partitions and floor reinforcement but no other work will be carried out at the Organizers's expense, provided that they are notified one month before the opening of the event. After that date, any modifications will be invoiced to Exhibitors.

**SUBCONTRACTING** - Article 13 - Exhibitors may, if they wish and agree to accept full liability, subcontract to third parties, hereinafter referred to as subcontractors, all or part of the site allocated to them, subject to the following conditions:

- that subcontractors concerned must not previously have been involved in a major conflict with the Organizers,
- that the contract between the Exhibitor and the subcontractors must include as an integral part:
  - all the clauses in the Organizers' general terms of sale that may be applicable to them, and no provisions constituting modifications or waivers to these terms,
  - a clause whereby Exhibitors' subcontractors waive the right to make any claim on the Organizers for any direct or indirect damage or moral prejudice that the Organizers may cause to Exhibitors, their subcontractors, their goods, their representatives, or goods belonging to the latter,
  - an irrevocable commitment on the part of the Exhibitors' subcontractors to obtain a waiver in the same terms from their insurance company

Exhibitors guarantee the Organizers that these waivers will be provided by subcontractors and their insurance companies and agree to compensate the Organizers for any direct or indirect consequences of any legal or informal claims or proceedings against the Organizers on the part of Exhibitors' subcontractors, their representatives and/or their insurance companies including expenses and fees that the claimant may have paid to enforce their rights. The fact that Exhibitors may have contracts with subcontractors does not modify their contractual relationship with the Organizers in any way - Exhibitors remain solely liable to the Organizers for ensuring that the contract is perfectly executed. Exhibitors' subcontractors will be considered by the Organizers to have been authorized by the Exhibitors to act on their behalf.

**DEMONSTRATION MACHINES AND EQUIPMENT** - Article 14 - All demonstration machines must be equipped with a safety system. Demonstrations must always be free of charge for visitors.

**SIGNS, POSTERS** - Article 15 - It is prohibited to place advertising boards or signs outside stands, other than in places reserved for this purpose. In case of any breach of this regulation, the Organizers will have the offending item removed, at the Exhibitor's expense and risk, without prior notice.

**PURCHASE COUPONS** - Article 16 - Exhibitors agree to accept any purchase coupons that may be circulated by the Organizers during the event. These coupons will be invoiced directly on presentation to the CEB.

**CLEARING SITES** - Article 17 - All sites must be returned to their initial condition at the Exhibitor's expense and cleared within 24 hours after the event closes. If, for any reason, the site is not in a proper condition for use on the specified date, or if it has been damaged, or if it is not in the same condition as it was when the Exhibitors set up their installation, the Organizers may use any means they think appropriate to clear the site completely or have it cleared and carry out any necessary repairs. Exhibitors hereby authorize the Organizers:

- to destroy all consumable equipment and installations,
- to remove and store any other equipment, installations, and goods on the site, as the Organizers see fit,
- to return the site to its initial condition,
- and to carry out any necessary work.

All these operations will be carried out at the Exhibitor's expense and the Exhibitor expressly waives any right to make a claim against the Organizers concerning the destruction, removal, or storage of goods, repair work, or any of their consequences. Exhibitors agree to make every effort and to take, with the greatest urgency, any action including legal proceedings to ensure that the site is actually returned to the Organizers as rapidly as possible, in proper condition, having repaired any damage.

**COMPULSORY INSURANCE** - Article 18 - Exhibitors are required to subscribe to an insurance policy with the insurance company approved by the Organizers, covering risks to themselves and their employees, as well as those they may cause to third parties.

The insurance premium covers:

1 \*) Goods and equipment exhibited, as well as stand fittings and installations, up to an initial claim of 7,650€. Exhibitors' coverage is strictly limited to material damage and excludes loss of use, profits, or business. Theft is not covered during setting up and stand clearance.

2 \*) Exhibitors' Civil Liability towards third parties for all bodily injury and (or) material damage, and (or) moral prejudice caused by their activities or those of their representatives. Exhibitors waive all right to claim against the Organizers, the owners of the exhibition site, and their insurance companies, for any bodily injury, material damage, and moral prejudice that they or their representatives may suffer.

**FOOD PRODUCTS** - Article 19 - All stands presenting food products must comply with the regulations in force especially with regard to hygiene and food safety as well as the operating procedures implemented. The exhibitor will be solely responsible for the consequences, in particular in case of intoxication and already renounces all recourse against CEB.

**WORKING CONDITIONS ON THE EXHIBITION SITE** - Article 20 - During site setting-up and clearance, as well as throughout the event itself, Exhibitors agree only to employ properly declared workers, under the conditions established by current law and regulations on working conditions. Subcontractors will be obliged to apply the same conditions. Inspections may be carried out on the initiative of the Labour Inspection Department during the preparation phase and the event itself.

**SALES PRACTICES** - Article 21 - Documentation may only be distributed inside stands. Likewise, visitors must not be bothered or harassed in the aisles. Advertising one's wares in a loud voice or using a microphone and soliciting are strictly prohibited. Advertising involving prices and the distribution of give-aways are subject to the general regulations laid down in ministerial orders. It is prohibited to advertise products other than those specified on the application form in any way whatsoever. Forced sales are strictly prohibited.

**SOUND ON STANDS** - Article 22 - The microphones are strictly prohibited. The sound systems should not exceed the standards allowed in terms of noise under penalty of removal of the power supply without notice after the first warning. Any broadcast of recorded music must be declared to SACEM ([www.sacem.fr](http://www.sacem.fr))

**WITHDRAWAL PERIOD** - Article 23 - Pursuant to Article L224-59 of the French Consumer Code, before the conclusion of any contract between a consumer and a professional at the fair, the trader informs the consumer that he has no withdrawal period.

The contract offers made in the salons mention the absence of a withdrawal period, in clear and legible terms, in an apparent box. Moreover, the exhibitors display, conspicuously for the consumers, on a panel that cannot be less than the size A3 and in a size of character that cannot be less than that of the body ninety, the following sentence:

"The consumer does not have a right of withdrawal for any purchase made on this show"

**PARTNERSHIP** - Article 24 - In agreement with the organization of the Longines FEI World Cup TM Jumping, it is forbidden for any exhibitor to present any watch whatsoever, branded or not, on its stand or on any other space of the Jumping event International Bordeaux or Jumping the Expo.

**ATtribution OF JURISDICTION** - Article 25 - In case of dispute, the Courts of Bordeaux are only competent, express agreement between the parties.

**ANIMALS** - The presence of pets, even on a leash, is not allowed in the Exhibition Center and its various halls during the International Fair of Bordeaux.

**MICRO ADS** - Micro announcements are not accessible to exhibitors and only concern emergency situations. Only the organizer is authorized to pass messages through this way.
